



INTERNATIONAL CAMPING CARNET

As a member of the International Federation of Camping and Caravanning (F.I.C.C.), the FAMILY CAMPERS & RVers (FCRV), founded as the NATIONAL CAMPERS & HIKERS ASSOCIATION, is authorized to issue the International Camping Carnet (CCI) to its members. It confers a number of privileges on both the holder and the member club or association, as well as the site manager.

MEMBERSHIP IN A "LARGE CAMPING FAMILY".

Your CCI makes you a member of a large international camping family who respect the environment, the rights of other campers and the rules governing camp sites. Many campgrounds in Europe are owned and run by private clubs and are closed to non-members. Your CCI acts as an inter-club membership card to all of these private campgrounds who belong to the F.I.C.C.

PRIORITY STATUS

Whenever you find a Club displaying the F.I.C.C. sign, you can be sure of a welcome, information and service. Your priority status could entitle you to reductions, which the site manager might offer.

ADMINISTRATIVE SIMPLICITY

Your CCI serves as a family certificate and can be used instead of an identity card or passport for on site administration. Rather than holding your passport, the campground would accept your CCI. One membership covers the entire family: mother, father and all children under the age of 18.

THIRD PARTY INSURANCE

The third party insurance offered western European members is not available to North American members. However, North American members who have homeowners or renters insurance should check their own insurance, since most already include worldwide personal liability insurance. Automobile insurance must be secured separately in Europe and can be obtained wherever you rent your vehicle.

RIGHT OF ENTRY TO F.I.C.C. RALLIES

As an CCI holder you are entitled to register, through member Clubs or Associations, for the International Rallies organized by the F.I.C.C.. These are wonderful occasions for exploring new places and meeting campers from other countries.

MEMBERSHIP DATES AND FEES

Your membership in FCRV is an annual membership and runs twelve months from your join date. The CCI is issued with an expiration date which coincides with the FCRV membership expiration. Your annual family membership fee in FCRV is \$25.00, your International Camping Carnet is \$20.00, and the shipping and handling is \$10.00. Please send application at least 1 month prior to departure date.
