This is Queen Macey's first-place-winning Conservation Essay from the 2019 National Campvention.



Are turtles worth saving? In a world full of problems and species, this is a question worth asking. Are there good reasons to go out of your way to save endangered sea turtles? Sea turtles make up a part of two vital ecosystems, beaches and marine systems. If sea turtles were to become extinct, both the marine and beach ecosystems will suffer. Since humans use the ocean as an important source for food, and use beaches for many kinds of activities, weakening these ecosystems would have harmful effects. Sea turtles have been living and thriving in the world's oceans for one hundred-fifty million years. This is true, however turtles are now in more danger of extinction mostly because changes brought about by humans. If we alter the oceans and beaches enough that sea turtles become extinct, will those changes make it difficult for us to survive? And if we choose to do what's necessary to save sea turtles, might we save our own future?

Sea turtles lay about one hundred eggs in a nest and lay between three and seven nests during the summer nesting season. They lay their nests on dunes and beaches that can sometimes be damaged by human interaction with the ecosystem. Not every nest will hatch, not every egg will hatch, and not all of the hatchlings will make it out of the nest. But all the unhatched nests, eggs, and trapped hatchlings are very good sources of nutrients for the dune vegetation. The dune vegetation will take the nutrients from those nests and rejuvenate the plants. Healthier vegetation and stronger root systems hold down the sand in the dunes and protect the beach from erosion. This means that sea turtles are helping to reduce the damaging effects human have on dune vegetation. But as the number of turtles declines, fewer eggs are laid in the beaches, providing less nutrients. If sea turtles

became extinct, dune vegetation would lose a major source of nutrients and would not be healthy or strong enough to maintain the dunes, causing beaches to be wash away.

Sea turtles are omnivores, meaning they eat both plants and animals. One species sea turtles eat are jellyfish. By the sea turtles reducing the number of jellyfish in the ocean this preventing the large "blooms" of jellyfish, including stinging jellyfish, that are increasingly wreaking havoc on fisheries, recreation, and other maritime activities throughout the oceans. Research shows that sea turtles often times act as keystone species in the sense that other species are largely dependent on them in the ecosystem. Seagrass beds are grazed by green sea turtles more productive than those that aren't. Hawksbill turtles eat sponges, preventing them from out-competing slow-growing corals. Both of these grazing actions maintain species diversity and the natural balance of a fragile marine ecosystems. If sea turtles became extinct, it will cause declines in all the species whose survival depends on healthy seagrass beds and coral reefs. That means that many marine species that humans harvest would be lost. Sea turtles come into play in our lives in more than one way, even when we don't know it. These are some of the roles that we know sea turtles play in the essential health of ecosystems. If you enjoy beautiful beaches maybe you should think twice about how you are affecting them. Like Kaya Korona agues, "While humans have the ability to tinker with the "clockwork" of life, we don't have the ability to know when it's okay to lose a few of the working parts. If you disagree, try to take apart a clock and just throw away one of the pieces that doesn't look that important. Put the clock back together and see if it still works." Will you help save the turtles?

DASAY MOMENT by Marilyn Rausch

We are in the last part of the year, and that means many of us are "making our lists and checking them twice." Thanksgiving is the traditional start of the Christmas shopping season! A few precautions can help "make the spirit bright" and prevent the headaches of becoming a victim of crime.

A word of wisdom before starting the whirlwind of shopping and entertaining: Keep it simple! It is not essential to buy everything or attend every event or even decorate elaborately for Christmas to be celebrated well. Nothing destroys the joy of the holidays as does the stress of unreasonable demands that we put on ourselves...except maybe the stress of having lost significant security and funds to a Christmas thief.

Shopping is best done during the day, if possible, and never alone. Avoid making yourself a target for thieves with these hints:

- * Carry as few valuables with you as possible. Avoid big purses, large amounts of cash, expensive jewelry. If possible, carry any cash, credit cards, etc. in a front pocket.
- * Record your credit card numbers in a safe place. If a card is missing, do not assume it may show up later. Report it to the credit card company or bank immediately.
- * Keep alert to your surroundings. Avoid walking while talking on your phone or texting.
- * Avoid overloading yourself with packages, limiting mobility and visibility of your surroundings.
- * Do not keep packages visible in your vehicle.
- * Beware of strangers approaching you for any reason. One person may try to distract you as another takes advantage of that distraction by taking your "stuff."

If you are more inclined to shop online, there are a whole other set of precautions:

- * Only shop on websites you know and trust.
- * If a website is unfamiliar, use social media or Better Business Bureau to get customer references. Try to contact the business (if they have no email address, phone number, or address available, they may be a fraudulent site out for your money.)
- * Compare prices. If a deal seems too good to be true, it might be just that.
- * Do not shop on public Wi-Fi unless you have installed a VPN (virtual private network), This will secure your use of the internet. Public Wi-Fi can be easily intercepted, and your data...card num-

bers, etc...can be easily compromised.

- * Use a strong password that mixes at least 10 characters, upper case, lower case, numbers and symbols included. Do not use the same password on more than one account.
- * Check your credit and bank statements regularly, at least once a week. If fraud is reported early, it may be partially refunded. After 60 days, you may not be reimbursed at all.
- * Keep as much information on the online purchase as possible: receipts, confirmation numbers, postal tracking numbers. If the purchase does not arrive, contact the merchant. If you do not get help there, contact your credit card provider.

Once the gifts are home and wrapped, the precautions are not over.

- * Place packages where they are not visible from windows.
- * If you are gone during the holidays, use a timer in your home to make it appear someone might be home.
- * If travelling, arrange for someone to remove your mail (or suspend mail delivery), newspapers, and snow from your home so it does not suggest you are not there. A neighbor might even park in your driveway or move your cars around while you are gone.
- * Do not open your doors to strangers. Unexpected package delivery people, door-to-door "charity" solicitors, etc. should show official identification before you interact with them.
- * If a delivery is expected, track it online or ask for email verification of delivery. If you are not going to be home, see if packages can be delivered to a trusted neighbor, be held at the post office, or can be delivered to a "safe" area (some packages can be delivered to local businesses for safekeeping...check with UPS or FedEx about their policies.)
- * After gifts are opened, do not put the empty boxes in a place where others can see what you have received... a nice big-screen TV box may lure a thief to your home!

So celebrate the Holidays with reason and safety, and build memories that will last a lifetime. Those memories rarely are built on material things, though the gifts are certainly a part of the celebration. Common sense and precaution can ensure that the greetings will become fact: Happy Thanksgiving and Merry Christmas!!

Ingredients:

- 1 30oz. bag of frozen diced hash browns
- 1 32 oz box of chicken broth
- 1 can of cream of chicken soup (10 oz)
- 1 pkg. cream cheese (8 oz, not fat free)

3 oz bacon bits

1 cup shredded cheddar cheese

salt and pepper to taste

Directions:

Put the hash browns in the crockpot. Add in the chicken broth, cream of chicken soup and half of the bacon bits. Add a pinch of salt and pepper.

Cook on low for 7-8 hours or until potatoes are tender.

An hour before serving, cut the cream cheese into small cubes. Place the cubes in the crock pot. Mix a few times throughout the hour before serving.

Once the cream cheese is completely mixed in, it's ready to serve. Top with cheddar cheese and some additional bacon bits. Enjoy!

This was approved by the Trustees and the rate set at \$325 CDN. Because currency changes daily the amount in US dollars isn't certain but should be between \$240 USD and \$260 USD. You have to go to your bank and let them know that you need <u>Canadian funds in a money order.</u> Not all banks do this, so you have to find out which ones do, and you make have to give them a couple of days to do this.
