Year 2030


Son: Mom we are learning about the pandemic from 2020 in school. what do you remember?

DASAY MOMENY by Marilyn Rausch



It hasn't been easy, but with faith and grit and ingenuity, we are making our way through the inconveniences of the current Coronavirus pandemic. What have we learned?? How will we be prepared for the next Pandemic...or other disaster...that may come along. We know now that we must be personally ready for whatever may come our way.

The government provides information on how to prepare and act in almost any situation. If you have not previously done so, I urge you to go to **READY.gov** to see the wealth of information that is there for you.

Some basic things that you should keep on hand in advance for *any* emergency include:

- Supplies of drinking water and stable foods. Include baby formula if that applies.
- Keep a 2-4 week extra supply of necessary prescription drugs (rotate them out with your daily supply to keep them fresh.)
- Keep a supply of nonprescription drugs and other health supplies on hand for emergency use (pain relievers, stomach remedies, cough and cold medications, etc.)
- Keep copies/electronic versions of health records for each member in the household, especially relating to chronic illness, medication allergies.
- Keep open communication with family members about emergency contacts, health decisions, other information important to them.

The whole country...indeed, the whole world...has come together to meet the challenges of this Pandemic. We cannot reasonably expect that someone else will be available to rescue us the next time. For that reason, it is up to each of us to do our best to be prepared for whatever comes in the future...and it will.



INGREDIENTS: topping

- ♦ 1 cup Flour
- 1/2 cup brown sugar
- ↓ 1/2 cup white sugar
- 1/2 tsp ground cinnamon
- 1/4 tsp ground nutmeg
- ♦ 1 pinch salt
- 1/2 cup butter, cut into pieces
- 1 cup chopped walnuts

INGREDIENTS: filling

- 1/3 c white sugar
- 1 tbsp cornstarch
- 1/2 tsp ground ginger
- 1/2 tp ground cinnamon
- 6 cups apples, peeled, cored and chopped
- 2 tbsp lemon juice

DIRECTIONS:

- 1. Mix all topping ingredients except the butter and walnuts in a bowl. Add butter and "cut" with fingers, fork, or pastry cutter until coarse crumbs form. Stir in walnuts and set aside.
- 2. Whisk together the dry filling ingredients. Place the apples in a slow cooker and toss with lemon juice. Stir in the cornstarch mixture.
- 3. Sprinkle the walnut-crumb topping on top.
- 4. Cook on high for 2 hours or on low for 4 hours, until apples are tender.
- 5. Partially uncover the slow cooker to allow the topping to harden (about 1 hour).
- 6. Serve warm with ice cream or whipped topping.

(hint: try using a liner in the slow cooker for easier cleanup!)
