Ingredients:

- \* 1 pound skinless, boneless chicken breast cubed
- \* 2 onions, diced
- \* 8 oz sliced fresh mushrooms
- \* 1 yellow bell pepper, sliced

- \* 1 red bell pepper, sliced
- 4 cloves garlic, sliced
- ∗ 4 small potatoes, cubed
- \* 1/4 c olive oil
- \* Juice of 1 lemon

#### Directions

- 1. Combine chicken, onion, mushrooms, yellow and red peppers, garlic and potatoes in large zip-top bag. Pour in olive oil and lemon juice. Mix well.
- 2. Evenly divide the mixture between 4 large sheets of aluminum foil. Top each with another sheet of foil. Roll the edges tightly. Wrap each packet again in another sheet of foil to double-wrap.
- 3. Cook in the hot coals of a campfire until the chicken is opaque and the potatoes are tender, around 40 minutes.
- 4. Be careful when opening foil as steam will have formed inside and can cause burns.
- (You can experiment with other types of protein and other vegetables.)



With the Coronavirus Pandemic, campgrounds (as well as almost every other business) were closed. As we enter recovery phase 3, campgrounds are again opened, but just what does that mean?

Everyone is anxious to get out and begin camping, and we miss the time camping together with our chapters, our state association, and our friends. But it is not yet as it was before, and we will face new restrictions. These restrictions are not randomly placed by the campground but are in adherence to CDC guidelines designed to help prevent continued spread and even possible resurgence of the Covid-19 crisis.

Indiana's "Suggested Guidance for Campgrounds" is summarized below. The full report can be accessed at

https://backontrack.in.gov/files/BackOnTrack-IN BackOnTrack-IN Guidelines-Campgrounds.pdf

General Operations:

- \* A minimum of 20 feet should be maintained between units for all lots rented for stay of less than 10 nights.
- \* Employees in public-facing areas are required to wear cloth face coverings over their nose and mouth. Customers are strongly encouraged to wear cloth face coverings.
- \* Campgrounds must provide handwashing in restrooms and sanitizing stations for guests and employees. If unable to adhere to these requirements, common restrooms and shared facilities must be closed.

#### Owners

- \* Campgrounds must increase routine cleaning and disinfection procedures with emphasis on frequently touched surfaces to be disinfected at least every 2 hours.
- \* Campgrounds should monitor groups and prohibit gatherings.
- \* Campgrounds should post signs promoting proper handwashing, maintaining adequate supplies for handwashing.

#### Shared Activity Areas

\* Guests must adhere to social distancing guidelines during recreational activities and must adhere to social gathering guidelines.

- \* Hot tubs, spas, splash pads, and contact sport activities should remain closed.
- \* Shared equipment during activities must be cleaned and disinfected after each use.
- \* Campgrounds should monitor use and post reminders for properly cleaning and social distancing near picnic tables, trash cans/dumpsters, and communal water areas.

#### Employees

- \* Campgrounds should train all staff on the proper use of personal protective equipment, including face coverings.
- \* Training should specifically cover topics like cleaning restrooms and collecting garbage.
- \* Campground employees should stay home if showing symptoms of illness.
- \* Campgrounds should set up a means of communicating with guests in ways that include no in -person contact, including at check-in.

Campground Guests

- \* All gatherings should be limited or restricted to social gathering guidelines.
- \* Campgrounds should monitor all public areas to encourage social distancing of guests. To achieve social distancing, guests should maintain 6 feet between persons not in the same household.
- \* Guests should be encouraged to bring disinfecting cleaners and hand sanitizers.
- \* Develop a protocol to conduct a health screening for guests at time of reservation and in time of check-in. Require guests who have been sick or have symptoms to stay home.
- \* Guests over 65 or with high-risk medical conditions are strongly recommended to stay home.

We have had our camping season seriously disrupted. Things seem better, but not yet normal. During the "Stay-at-Home" orders we learned what we must do to reduce our personal risk and help avoid spread of this virulent virus. We need to carry those lessons forward as we try to return to some of the activities that are now available to us again.

#### **CAMPING IS CONTEST**

Since many spring Campouts are being canceled, if we have the Campvention this year, all Camping Is entries from all states and provinces will come to Nationals to be judged. In addition, materials will be provided to create an entry at Campvention. There can be multiple entries in an age category from each state/province.

If Campvention itself is canceled we will run a contest using a photo of the poster or coloring page. Create your poster (ages 5-12) or color your page (ages up to 4) Take a picture of the entry and email the picture to <u>kssnodgrass@earthlink.net</u>. **Deadline would be June 15th.** Entries should indicate the child's name, state/ province, birth date and age.

We will still do ribbons or certificates to category winners.

#### **CAMPING IS CONTEST**


**"CAMPING IS"** is a contest to give the youth of FCRV an opportunity to express what camping is. The contest is divided into six age groups; 0-2 years, 3-4 years, 5-6 years, 7-8 years, 9-10 years, and 11-12 years. Ages 0-4 will have a coloring contest with an official coloring page required. Ages 5-12 will have poster contest.

#### RULES

- 1. Contestant or contestant's parent(s) or legal guardian(s) must be FCRV members.
- 2. For Coloring Contest (ages 0-4) an official coloring page is required. Coloring pages will be available from the State/Provincial Youth Director or from the State/Provincial Director. It should also be available for download from the youth page of the FCRV website (www.fcrv.org).
- 3. For Poster Contest (ages 5-12) posters must be a standard size of 22"x 28". Standard sized poster board or heavy paper of the determined sized may be used.
- 4. ALL work, coloring, drawing, lettering, etc. must be the youth's own work. Posters may be any media. Coloring contest entries may us any non-electronic drawing or coloring materials
- 5. Each State/Province may enter ONLY ONE ENTRY PER AGE at the National Contest level. These must be registered in the national contest.
- 6. Name, address(complete) and birth date, along with Field Director's or State/Provincial Director's certification of FCRV membership must appear in the lower left hand corner on the back of the poster/official coloring sheet.
- 7. Age will be determined as of July 1 of the year of the contest.
- 8. Each 1<sup>st</sup> prize winner becomes the property of FCRV for promotional uses. All others may be claimed at the end of Campvention.
- 9. Entries brought to the National Campvention must comply with the stated rules or they will be disqualified.

#### AWARDS

- 1. Ribbons will be awarded to 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place winners.
- 2. First place winners will receive an additional award (medallion or trophy) to be determined by National Contest Officials.
