



## DASAT MOMENT

We are finally there: Springtime after a pandemic. Cautiously we are preparing for that first campout. We have prepared our camper, collected our equipment, planned our menus and charted our routes. One more thing: are we weathersafe?

Campers are particularly vulnerable to severe weather changes from thunderstorms to floods to the most severe threat, tornadoes. If you haven't prepared for these, then you haven't prepared for a

safe camping experience! It is rarely safe to remain in your camper during a severe weather event.



Know the weather possibilities before you set out. *It* may be wise to delay or cancel your campout if the risk is high. Keep a weather alert radio or have a weather app on your mobile device that can warn you of ongoing threats or sudden changes. WATCH means conditions are ripe for severe weather and you should be on guard. A WARNING means that the weather conditions are present and you need to take immediate evasive action.

#### BE PREPARED!

Keep an emergency kit prepared and handy to grab for a fast getaway. Include bottled water and snacks, jackets, first aid kit, battery operated flashlight and radio, prescription medications, insurance information and cash. Keep sturdy shoes by the door of your camper.

## **TORNADOES**

When you arrive at a campground, determine where you will go in tornado. An underground location would be ideal. Ask your campground owner where they would designate a safe place. If nothing else, try the campground bathhouse, putting as many walls as possible between you and the outside, avoiding all windows. A last option would be to lie as flat as possible in a ditch, ravine, or other lowlying area. Generally you cannot outrun a tornado, but if it is the only option, get into your vehicle, put on seat belts, and lie as flat as possible on the seats so you are least exposed to breaking glass and collapse of the upper structures of the vehicle.

## **THUNDERSTORMS**

Being outdoors is always a hazard during a thunderstorm. Tents do not provide any safety from lightning. Open-sided shelter houses generally provide



little protection. THERE IS MORE DANGER THE MORE CONTACT YOU HAVE WITH THE GROUND. If caught outdoors in a storm with no place to go, assume the "Lightning position": bring your feet tightly together, preferably on top of an insulated bag. Crouch down over your feet and wrap your arms around your knees. DO NOT SIT DOWN...avoid 2 points of contact with the ground. (obviously, this is difficult to do, so it is best not to allow yourself to be in the situation needing it!)

You may find the most safety outside of a building in an all-metal vehicle. Avoid touching anything metal inside the vehicle. Tires do not "ground" a vehicle or a camper...the safety comes from the "faraday" effect where the lightning current follows the metal skin of the vehicle, avoiding those inside.

#### WIND

We all know the problem of towing a rig in the wind. We also know what damage can be caused to one's awning from a gust of wind. Again, awareness and preparation are key. Look for hazards in your campsite (dead or dangling branches, unstable structures). Anchor down or stow any loose items like rugs, chairs, etc.

#### FLASH FLOODS

That gentle stream near your campsite has the potential of becoming a raging disaster without significant warning because of rain or runoff from rain elsewhere. It is better to set up farther away from any water source and, of course, to be aware of past history and current conditions. Never walk or drive through standing water. Be aware of hidden hazards in flood waters.

May your camping trips be blessed with great weather, but if that doesn't happen, may you be prepared for whatever comes. Safe and happy camping!!

# Recipe worth Sharing

**CAMPING QUESADILLAS** 

(4 servings)

## **Ingredients**

4 medium flour tortillas

2 8oz chicken breasts, grilled and sliced

1 jar Tostitos salsa con queso

1 can black beans rinsed and drained

1 c. shredded Mexican blend cheese tin foil

## **Instructions**

- 1. Spread 1 Tbsp salsa con queso over one side of a tortilla.
- 2. Place 1/4 c. chicken on half the tortilla over the salsa con queso. Sprinkle 1/4 c. black beans and about 1/4 c. cheese over the chicken.
- 3. Fold other side of tortilla over to cover ingredients. Place on a piece of tin foil large enough to cover the quesadilla. Leave the ends open.
- 4. Place the foiled quesadilla on the grate directly over the campfire. Keep over fire to cheese is melted and tortilla is crispy.

Remove from the grate and cut in four pieces. No plates needed because you have the foil!




