Message From the President



As you are reading this, Thanks-giving 2021 is now a memory for you and Christmas will be here in very short order. The weather we've been enjoying has been terrific and I hope that all of you have been able to get your outside chores completed before Winter 2021-22 decides to settle in for real.

While most RVs have recently been winterized and put into storage, it's certainly not too soon to begin planning your trips for next year. The first big trip for most of us will be the 50th Anniversary of the FCRV International Retiree Rally. To be held at the Mineola Civic Center in Mineola TX, the rally is to run from March 29th to April 3rd, 2022. Early days are set to run from March 25th to

March 28th.

A bit later on in the summer will be FCRV's 62nd International Campvention. The 2022 edition will be hosted by the Far West Region 1 at the Colorado State Fairgrounds in Pueblo, CO. Campvention Days are planned to run from July 10th to the 15th. Early Bird Days are going to be July 8th and 9th. Pre-registration for Campvention will end on June 1, 2022. Registration forms for both the Retiree Rally and the Colorado Campvention can be found at the back of the current and last several issues of FCRV's newsletter, Camping Today. On the forms you will find all the particulars including costs and information on arrivals and parking. As Paul Standiford noted in a recent email, the organizers of the Pueblo Campvention are looking for a number of volunteers to chair and co-chair various committees. If you are planning on going to Pueblo next July, you might give some consideration to helping them out and participating in getting the Campvention planned and run.

Not to be overshadowed by the national events are MSCA's own Spring and Fall Campventions. The MSCA Spring Campvention will once again be held at the Big Red Barn RV Park in Carthage, MO. Dates for 2022 will be April 29th, 30th, and May 1st. The MSCA Fall Campvention will once again be held at the Lazy Day Campground in Danville, MO. Dates for the fall campout are September 9th, 10th, and 11. You can easily set your reservation so that you can go in a day or two early, &/or stay a day or two later at either campground. If you're going to attend either Carthage or Danville, consider making your trip a bit more than just the "official" 2 nights. It makes all the effort to pack the RV and drive from wherever all the more worthwhile.

We want to wish you all a happy, healthy, and safe Holiday Season. Merry Christmas to all and we hope you have a fantastic New Year. As I tell everyone in Pitch 'n Pull, stay warm, stay dry, and safe travels wherever you go.

Here's a quick and easy bar cookie that may surprise everyone you know.

Ouick Mix Tofu Cookie Bars

- 2 packages (18 oz.) refrigerated chocolate chip cookie or oatmeal chocolate chip, slice and bake cookie dough
- 1 package (12 oz.) firm silken tofu
- 2 eggs
- 1 cup sugar
- 1 tsp vanilla



Preheat oven to 350° F. Soften one roll of cookie dough. Spray the bottom of a 9" x 13" baking pan with non-stick spray. Line the bottom with the softened cookie dough, spreading to all sides. In food processor bowl, combine tofu, eggs, sugar and vanilla until smooth. Pour tofu mixture over cookie dough in pan. Drop second roll of cookie dough by teaspoons on top of filling. Bake for 40 to 45 minutes.

Yield: 36 bars. Per bar: 155 calories, 6 g fat (2 g sat fat), 18 mg cholesterol, 65 mg sodium, 23 g carbohydrate, 2 g protein (0.7 g soy protein), 0 g dietary fiber;

Darrel Thomas held a safety session on May 2, at the Big Red Barn immediately following the board of directors meeting. This session covered safety in your camper, whether it was a Class A, B, C, Travel Trailer or Fifth Wheel.

Darrel talked about fire extinguishers, carbon monoxide/gas detectors, weather alert radios and encouraged all to check to see if said items were in the proper working order in their

own camper. He also suggested getting these items for your camper if not already installed. After the discussion names were picked from a hat of those present for a giveaway of a carbon monoxide detector by Kiddie, an ABC fire extinguisher, a natural gas detector, a smoke detector, and a weather radio. Thank you all that showed up for the program.


