message that reservations must be made with the campground no later than August 21st to get the group rate of \$40.50 per night for full hookups plus a one-time \$5.00 reservation fee. When making reservations, be sure and tell them that you are camping with MSCA.

This year, Saturday morning will be spent doing a Conservation service project at Graham Cave State Park by all MSCA members that care to participate. As Richard and Frances wrote in the Summer Missouri Camper, the project will be done in the cooler morning weather, and you will want to pack work clothes in your camper before you head for Lazy Day. The Director's meeting and the General meeting will be held Saturday afternoon. We will be discussing and then voting on where we want to hold the MSCA Spring and Fall Campventions for 2024. If there is a campground that you want to have considered, please come prepared with more than a name. Check on cost, if they have 20-30 spaces available, if there is a meeting room (and cost), and whatever reservation deposit they require etc. We will also have an election of MSCA officers for 2024. If you are willing to run for an office, please contact someone on the Nominating Committee (Pat Crow, Don Hopkins, or Dave Gish), prior to the September 23rd Board Meeting. New people are needed for the MSCA offices of President, Secretary, and 2nd Vice President. Also, please consider filling one of the vacant Program Chairman positions. This is a volunteer organization and volunteers are always needed. If you are interested in filling one of those, please contact one of the MSCA officers. It's a wonderful way to help the organization without having to run for an office.

Rally Arrival: September 21, 2023 Rally Departure: September 24, 2023 Number of sites blocked off: 30 total.

Booking Date: Your club members must call and book by August 21, 2023. We will secure their reservation with a credit card. Two to three weeks prior to arrival, I'll send you an email with the listing of the campers who have booked with me. Anyone making a reservation after that time is not guaranteed a site.

Price per camper per night: \$40.50 per night includes 2 adults, one camper, and one vehicle. EV charging is extra. **Reservation System Fee:** A non-refundable \$5 per reservation fee is pulled at time of reservation.

Additional Adult per night: \$3 each per night.

Additional Vehicles: \$2 each per night.

Checking in: *Absolutely no checking-in before noon!* We are short staffed do maintenance work in the morning and can not be disturbed! Please forward this information to your cub members.

Clubroom: \$20 for the first night, \$10 per night after payable upon arrival from the wagon master or treasurer. It is your responsibility to collect from your members. You will then have access to our club room which offers a fully functional kitchen, tables with seating to accommodate up to 70 people with a charcoal grill and some seating under an attached pavilion outside.

Pets: Due to the safety of others and allergies, pets are no longer allowed in any buildings unless preapproved by staff. Please be respectful to those who may not be animal lovers. This does not include service dogs, however they MUST wear their service vest at all times. We have a half acre, fenced-in dog park for your four legged friends to run around in while they're here.

Sites: Level Big Rig friendly gravel base, shaded and open sites, up to 50 amp service, FHU and pull through. Picnic tables and fire rings are at each site.

Amenities: There is a three acre, fully stocked catch and release lake, (no licensing required), a large swimming pool (seasonal), half acre fully fenced in dog park, small gift store with necessities, large laundry room, handicap accessible bathroom and showers, free Wifi, firewood and propane sales. Do not bring firewood into our park!!

Location: Interstate 70, Exit 170 for Danville, South 1.5 miles on Highway J to campground entrance on left hand side. **Damage:** Damage made by campers to their site or the facilities is their responsibility, and there may be fees incurred. Please do not use outdoor carpets on your site as they may kill the underlying grass within hours. Refrain from smoking in any buildings on the property, and do not cut or trim any trees. Please inform the office as soon as possible about any defective equipment or damage you may find on the campground so that we may repair it in a timely fashion. **Cancellation Policy**: Campers MUST call a minimum 72 hours in advance of their arrival date to cancel their reservation. Those canceling within the 72 hours or simply don't show will be subject the daily rate up to three nights due to a rentable site being held. **Should the entire club cancel for any reason, we MUST have a FOUR WEEK minimum notice.** If

Should the entire club cancel for any reason, we MUST have a FOUR WEEK minimum notice. If cancelling within that time frame, fees will be involved and a possibility of losing the opportunity to stay with us in the future.

Payment: We accept cash, check and all credit cards. **There is a 3.5% surcharge on all card transactions.** We look forward to having y'all stay with us!
