APRIL 8, 2024: TOTAL SOLAR ECLIPSE IN THE PATH OF TOTALITY

Eye Safety During a Total Solar Eclipse

Much of Indiana will be in the rare "Path of Totality" during the historic April 8, 2024 Solar Eclipse.

Except during the brief total phase of a total solar eclipse, when the Moon completely blocks the Sun's bright face, it is not safe to look directly at the Sun without specialized eye protection for solar viewing.

When watching the partial phases of the solar eclipse directly with your eyes, which happens before and after totality, you must look through safe solar viewing glasses ("eclipse glasses") or a safe handheld solar viewer at all times. **Eclipse glasses are NOT regular sunglasses**; regular sunglasses, no matter how dark, are not safe for viewing the Sun. Safe solar viewers are thousands of times darker and ought to comply with the ISO 12312-2 international standard. NASA does not approve any particular brand of solar viewers.


Do NOT use eclipse glasses or handheld viewers with cameras, binoculars, or telescopes. Those require different types of solar filters. When viewing the partial phases of the eclipse through cameras, binoculars, or telescopes equipped with proper solar filters, you do not need to wear eclipse glasses. (The solar filters do the same job as the eclipse glasses to protect your eyes.)

Seek expert advice from an astronomer before using a solar filter with a camera, telescope, binoculars, or any other optical device. Note that solar filters must be attached to the front of any telescope, binoculars, camera lens, or other optics.

Important safety guidelines to follow during a total solar eclipse.

- 1. View the Sun through eclipse glasses or a handheld solar viewer during the partial eclipse phases before and after totality.
- 2. You can view the eclipse directly without proper eye protection only when the Moon completely obscures the Sun's bright face during the brief

- and spectacular period known as totality. (You'll know it's safe when you can no longer see any part of the Sun through eclipse glasses or a solar viewer.)
- 3. As soon as you see even a little bit of the bright Sun reappear after totality, immediately put your eclipse glasses back on or use a handheld solar viewer to look at the Sun.

Even a common kitchen colander can be used to "project" the eclipsing sun onto the ground! Simply hold it in the path of the sun and see many little eclipsing suns

AVOIDING A SAND TRAP

On February 20, 2024, the unthinkable happened to a family from Fort Wayne, Indiana, who were vacationing in Florida. The parents were right there as their 2 children were happily digging in the sand. Suddenly their daughter was gone, buried in the collapsing sand, and their son was nearly buried. Tragically, 7 year-old Sloan Mattingly died. Why did that happen?

When planning for safety on the beach, our minds turn to the obvious: stay hydrated, wear sunscreen, don't swim alone, watch out for dangerous swimming conditions. Playing in the sand is not top on our list

of warnings.

Sand is basically unstable. The fine grains mixed with water and air will hold together enough to build the towers of a sand castle and the walls of a trough. At some point, though, the weakness of the structure of the sand causes it to slump or shift, causing it to level out again. Anything that is in the way of its leveling out will be buried.

Five gallons of sand weighs about 70 pounds dry, up to 90+ pounds wet, as it would be on the beach. The weight of even a small layer of sand makes it difficult to move, so it is usually not possible to dig one-self out when buried. When compressed against the chest, the weight of sand prevents the chest movement required to take a breath. As a result, even being partially buried could result in death.

Regarding playing in the sand, a basic premise should be followed:

A SHALLOW HOLE IS A SAFE HOLE.

1. Never dig deeper than the knee level of the *smallest* person present.

2. NEVER put your head below the level of the surrounding sand. If the sand collapses, your

head could become trapped.

3. Avoid digging or tunneling into the side of a sand hill or a berm. The weight of the sand above will cause that horizontal digging to collapse.

We have all seen the people who are "buried" in the sand with only the head exposed. The safe way to accomplish that is for the person to recline on the sand and have others shovel sand over their bodies in a thin layer, avoiding the head, giving the appearance but not the reality of being buried.



BEYOND THE SAND CONCERNS

Safe beach time does include the other recommendations more generally given:

1. Avoid dehydration. Drink plenty of non-

alcoholic beverages.

- 2. Avoid sunburn. Use (and reapply frequently) sunscreen. Avoid the midday sun. Wear UV certified sunglasses and protective clothing. Remember that you can sunburn even on an overcast day!
- 3. Be weather aware. Lightning is a real danger around water. If you hear thunder or are aware of an approaching storm, get out of the water and leave the beach area.
- 4. **Never** swim alone.

SPECIAL PRECAUTIONS WHEN VACATIONING AT THE OCEAN

Further precautions are needed when swimming by the ocean. Public beaches employ a flag warning system to advise of potential safety concerns. Colors indicate the risk.

1. Double red: Water closed to the Public.

- 2. Single Red: High hazard (high surf, strong currents)
- 3. Yellow: Medium hazard (moderate surf and currents)
- 4. Green: Low hazard, calm conditions, use caution.
- 5. Purple: Dangerous marine life (usually jellyfish).

Note: an absence of flags does not assure safe water.

Ocean swimming has some unique conditions requiring attention.

- 1. Ocean currents can carry you away from your starting point. Pick out a landmark where you enter the water and keep an eye on it. Preferably, swim in front of a lifeguard, and avoid water deeper than waist deep.
- 2. Rip currents flow *away* from the shore. They don't pull you underwater, but can pull you seaward faster than you can swim.
 - a. Remain calm.
 - b. Don't fight the current, but swim out of the current in a direction that follows the shoreline. When out of the rip current, swim at an angle toward the shore and away from the current.
 - c. If unable to swim out of the current, float or calmly tread water, draw attention to yourself by lifting your arm and yelling for help.



HASH BROWN QUICHE CUPS

INGREDIENTS: CRUST

1 large egg 1/4 tsp salt 1/8 tsp pepper

2 c. frozen shredded hash browns, thawed

1/4 c. shredded Asiago cheese

INGREDIENTS: FILLING

3 large eggs

1 tbsp minced fresh chives

1/3 c. shredded Colby-Monterey Jack Cheese

1/3 c. fresh baby spinach, thinly sliced

2 bacon strips, cooked and crumbled

DIRECTIONS:

1. Preheat oven to 400 degrees. Grease 8 muffin cups.

- 2. Make crust: whisk together egg, salt and pepper. Sir in potatoes and Asiago cheese. Press 1/4 cup of the crust mixture into the bottom and up sides of each muffin cup. Bake until light golden brown (14-17 minutes.
- 3. Make filling: whisk eggs and chives until blended. Stir in cheese and spinach. Spoon into crusts and top with bacon. Return to oven and bake until a knife inserted in the center comes out clean (6-8 minutes).

What about Pets during the Eclipse?

Information from Ohio State University College of Veterinary Medicine indicates that "Dogs, cats, birds, etc. do not normally stare at the sun; they heed their natural reflexes not to look (unlike us curious humans.) Since they have an aversion to bright light emitted by the sun, the discomfort of squinting generally overrides any curiosity they may have, and they are likely no more inclined to stare at the sun than they normally would."

If animals are weather sensitive, they may be more affected by the rapid changes in temperature during the event. For that reason it may be advantageous to keep pets indoors during the event.

Many zoos, including the Indianapolis Zoo, will be monitoring their animals to detect any behavioral changes that the eclipse might trigger.



FRENCH TOAST CUPS

INGREDIENTS

5 eggs

1 cup milk

3 TBSP sugar + 2 tsp. cinnamon, mixed

1 tsp vanilla

12 slices of bread, cubed

DIRECTIONS

- 1. Grease well the cups of a muffin pan. Preheat oven to 350 degrees.
- 2. Mix first four ingredients.
- 3. Stir the bread cubes into the egg mixture.
- 4. Divide evenly into the muffin pan cups. Sprinkle with additional cinnamon/sugar.
- 5. Bake for 25-30 minutes.
- 6. Serve with powdered sugar and syrup.
